Cultural Funding by Government—2021–22

South Australian Government

The estimate of expenditure funded by the South Australian Government in 2021–22 for cultural activities was **\$296.0m** representing an increase of 27% or \$62.7m from 2020–21. This amount includes **\$11.3m** COVID support funding for cultural and creative organisations and infrastructure, businesses, individuals, support programs and initiatives.


- Recurrent expenses accounted for 82% (\$243.5m) of funded cultural expenditure.
- Capital expenditure was \$52.5m. Variations between 2020-21 and 2021-22 are due to higher expenditure in 2021-22 for Other museums and cultural heritage (\$29.0m) and Performing arts venues (\$15.2m).
- The estimate of per person funding was \$163.80.

Funds on Total Heritage activities (recurrent and capital) rose 25% (or \$23.4m) to \$115.9m.

Expenditure on *Other museums and cultural heritage* increased by \$23.0m, *Art museums* (\uparrow \$1.2m), *Archives* (\uparrow \$0.5m), with a fall in *Libraries* of \$1.3m.

The largest categories of *Heritage* expenditure were *Other museums and cultural heritage* with \$59.9m, followed by *Libraries* with \$35.1m.

Funds for Total Arts activities (recurrent and capital) grew by \$39.3m (↑28%) to \$180.1m.

The largest increases were in *Performing arts venues* (\uparrow \$20.6m), *Film and video production and distribution* (\uparrow \$13.5m), and *Design* (\uparrow \$4.9m).

Performing arts venues (\$61.4m), accounted for just over one-third (34%) of all funded expenditure by the South Australian Government on *Arts* activities.

Other main categories of Arts activities funding were:

- Film and video production and distribution—\$21.4m
- Multi-arts festivals—\$19.3m
- Arts education—\$16.0m
- *Music*—\$12.9m
- *Theatre*—\$9.0m.

Total recurrent expenditure increased 12% (or \$26.5m) to \$243.5m.

The largest recurrent expenditure was for *Performing arts venues*, \$46.2m, followed by *Libraries* (\$34.9m) and *Other museums and cultural heritage* (\$30.9m).

The largest recurrent dollar increase was for the categories of *Film and video production and distribution*, \uparrow \$13.5m and *Performing arts venues* \uparrow \$12.5m, between 2020–21 and 2021–22.
