# The International Decade of Indigenous Languages Directions Group

Our International Decade of Indigenous Languages Directions Group (Directions Group) has met four times during 2022 and formed two sub-committees including:

- The logo subcommittee Worked with Gilimbaa to develop the Decade for Indigenous Languages logo in partnership with the Office for the Arts
- The priorities subcommittee Drafted the Directions Group priority areas and presented these to the Directions Group in Alice Springs.

In this time we have become a strong collective voice with representation from all corners of Australia. Our members hold deep knowledge and passion for their languages. Our Terms of Reference can be found <a href="here">here</a>.

### Alice Springs meeting 12-13 September 2022

We held our second face to face meeting on 12-13 September in Mparantwe on Arrernte Country. The meeting was opened with a Welcome to Country and a traditional Smoking Ceremony.

Building on the work of the priorities subcommittee, we discussed and agreed to a draft preamble for three priority objectives and five policy reforms that our group endorsed as a starting point for what we will advocate for as a collective voice.

#### **Draft preamble**

Language is a fundamental human right. Aboriginal and Torres Strait Islander languages are the first languages of Australia. They are the very essence of our identity, wellbeing and knowledge. They are our connection to Country, Cultures and Kinships.

Australia has one of the highest rates of language loss in the world. The impact of continuing colonial policies deliberately broke our connection to languages and therefore cultural and spiritual identity. The impact of these policies are still felt today.

Immediate action is required to reverse this loss to allow our languages and our voice to once again thrive and survive.

The Directions Group identified three reform objectives and five policy priority areas that require urgent action.

#### The three priority objectives include:

- Stopping the loss
- Ensure the safety and security of current investment
- Thinking about a new way forward





#### The five policy reforms include:

- Sector strengthening
- Access to education, employment and learning opportunities
- Community access
- Recognition, truth telling and celebration
- Develop a national approach

## **National Action Plan**

We discussed and agreed on a high-level framework for Australia's National Action Plan for the International Decade of Indigenous Languages. We took part in powerful discussions that informed the development of five themes that will shape Australia's National Action Plan for the International Decade, and will be visually represented in the Action Plan in the formation of a tree. The five themes are:

- Stop the loss
- Community is centre
- Caring for Country
- Intergenerational knowledge transfer
- Truth telling and celebration
