Cultural Funding by Government—2019—20

Victorian Government

The estimate of expenditure funded by the Victorian Government in 2019–20 for cultural activities was **\$587.3m**. This represented an increase of 7% or \$40.2m from 2017–18¹. This amount included **\$35.2m** of COVID support funding for eligible organisations, businesses, and individuals in creative and cultural industries.²


- Recurrent expenses accounted for 86% (\$503.8m) of funded cultural expenditure.
- Capital expenditure was \$83.6m, and the largest three categories were *Performing arts venues* (\$31.5m), *Film and video production and distribution* (\$28.3m) and *Art museums* (\$9.4m).
- The estimate of per person funding with COVID support was \$88.17, and without was \$82.89.

Funds on *Heritage* activities decreased 11% (or \$31.2m) to \$262.8m.

This decrease was driven by lower expenditure on the categories of *Other museums and cultural heritage* (\downarrow \$25.5m) and *Libraries* (\downarrow \$18.9m). Decreases were offset by an increase in *Art museums* (\uparrow \$14.3m).

Over one-third (42%) of *Heritage* funds were spent on *Libraries* (\$109.1m).

Funds for Arts activities rose 14% (or \$36.3m) to \$289.4m.

Three main contributors to this movement were *Performing arts venues* \uparrow \$26.5m, *Film and video production and distribution* \uparrow \$25.8m, and *Theatre* \uparrow \$6.1m. Conversely, funding for *Cross-art form* dropped by \$22.6m due to completion of capital works.

The main categories of Arts activities funding were:

- Performing arts venues—\$73.5m
- Film and video production and distribution—\$60.4m
- Arts education—\$38.6m
- Music—\$13.0m.


Total recurrent expenditure increased 13% (or \$56.2m) to \$503.8m (including \$35.2m for COVID support funding).³

The largest recurrent expenditure was for *Libraries*, \$102.1m, followed by *Art museums* \$65.3m, and *Other museums and cultural heritage* (\$54.6m).
